Scope:

The scope of this policy extends to the following areas:

- Clean & Green Campus
- Restricted entry of automobiles

Objectives:

- The Institute believes that greening the campus is all about eliminating inefficient waste, using conventional energy sources for daily power demands, treating garbage properly, buying eco-friendly goods, and having a strong recycling programme.
- The Institute's administration is of the opinion that everyone must devise time-bound plans for putting into action green campus activities. In order to create a clean and green campus, these techniques must be implemented into the institutional planning and budgeting procedures.
- Every person on the TSM Campus, including students, teachers, and support staff, will work to promote an environment-friendly campus and a culture of self-sustainability.
- The school will be able to create the campus as a living community thanks to the Green Campus Initiatives (GCI).

Policy:

- The policy is designed and framed to make TSM campus clean and green.

Green Campus Policy envisions a clean and green campus where environmentally responsible behaviour and education work together to advance ecologically friendly and sustainable activities both on and off campus. Additionally, it gives the organisation a chance to take the initiative in reinventing its environmental culture by fostering environmental ethics among the faculty and staff.

Initiatives Taken to Implement the Clean and Green Campus Policy

A. Energy Saving Promotion

The institute encourages students to save energy and discourages them from making inappropriate use of it. It encourages students to shut down their computers rather than log off, utilise LED lights, light up lecture halls and conference rooms only when necessary, and switch off monitors when not in use

B. Waste water Management/ Rainwater harvesting:

The Institute concentrates on waste water management, especially in student residences. Reduced water flow toilets, automatic urinal flushers, and faucet and shower water flow restrictors should all be used on campus. The Institute will conduct waste water management and rainwater harvesting by taking all necessary steps.

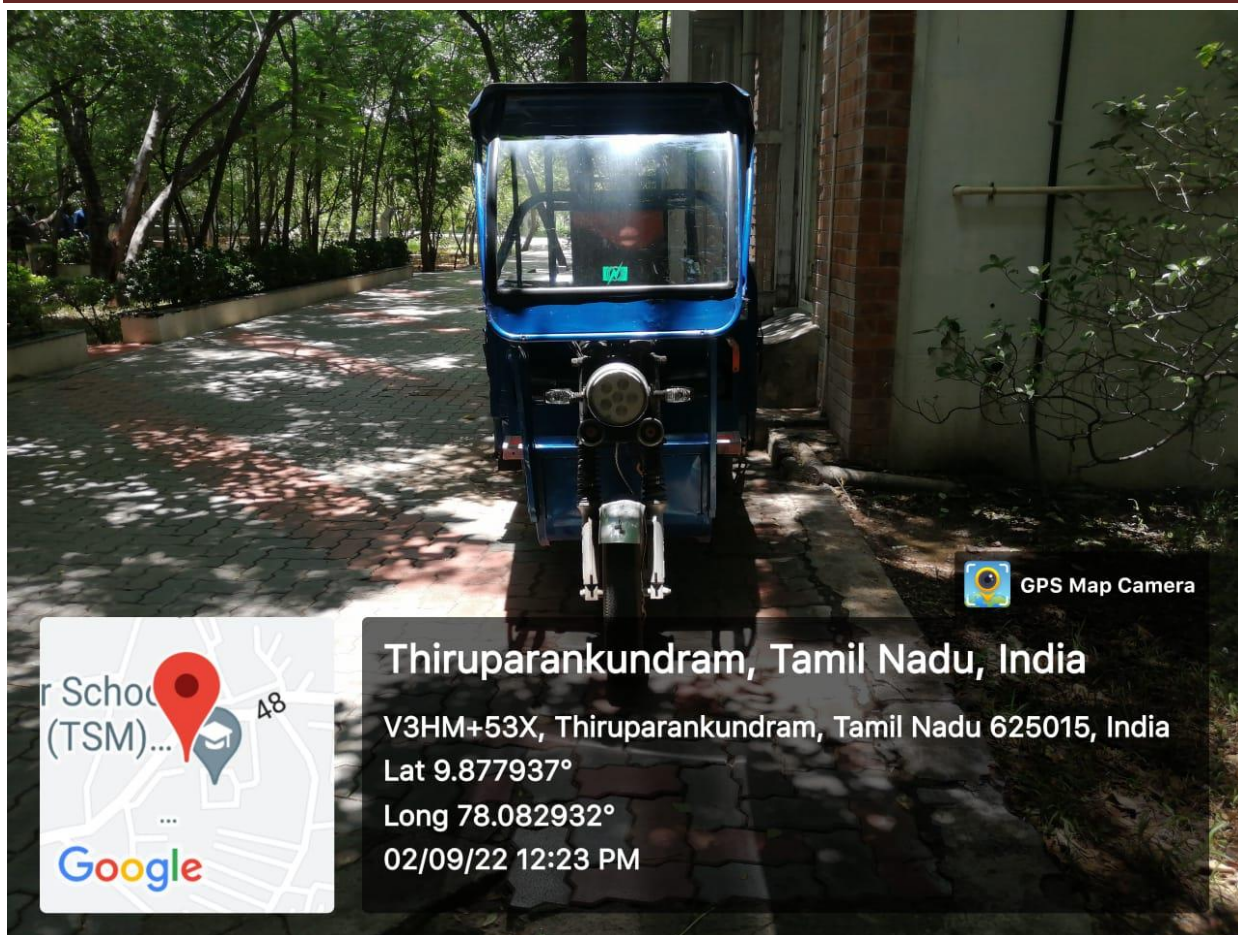

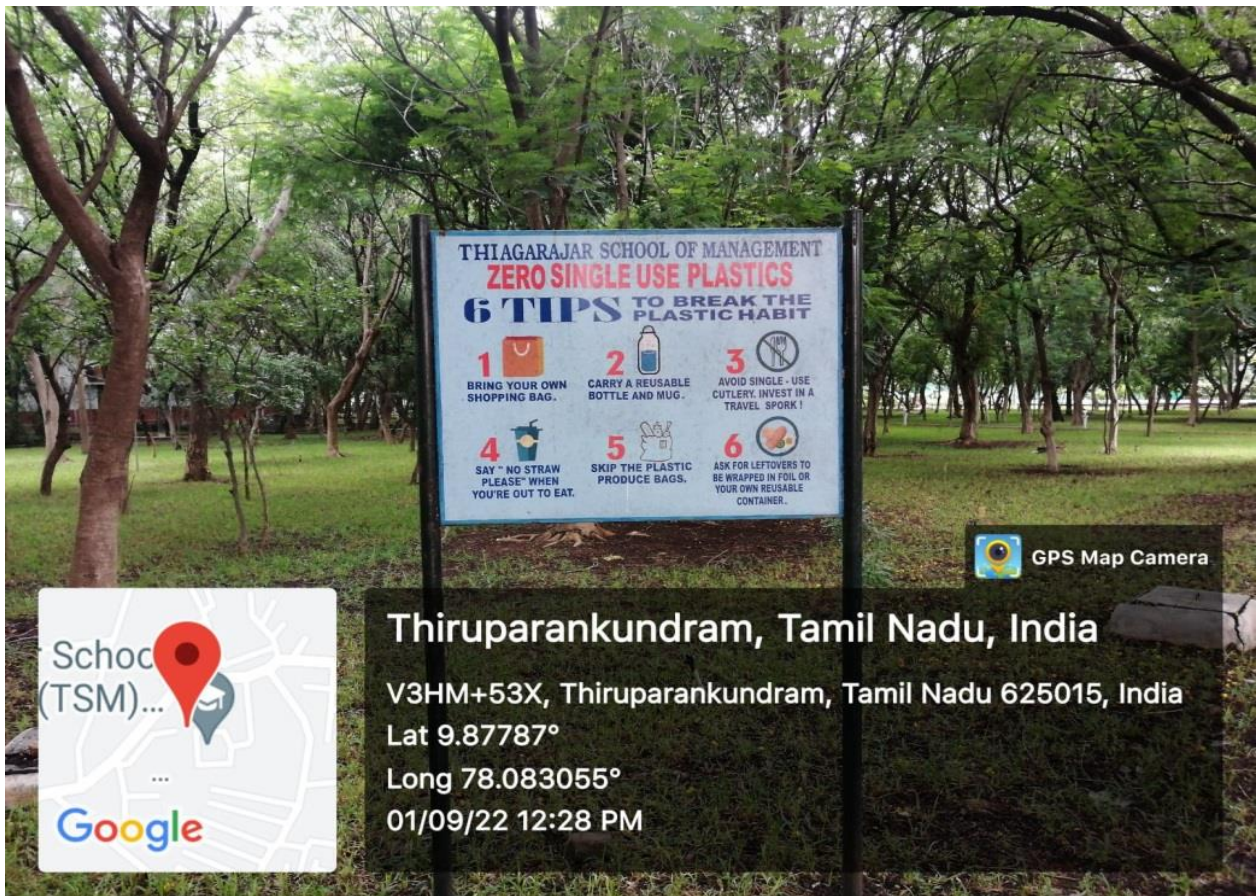
